# **Patient confidentiality**

We take patient confidentiality extremely seriously at Castle Street Dental Practice and all personal information is treated in the strictest confidence. Only members of staff have access to patient information. All our patient records are securely stored at our practice to ensure that any patient information is only accessed as part of your treatment. No information will ever be released to a third party without your express permission. We have a strict confidentiality policy. # Methods of payment

We accept the following methods of payment at the practice: cash and all major credit and debit cards.

NHS CHARGES ARE AS FOLLOWS: -

BAND 1

£14.70 this includes an examination, diagnosis and preventive care, X-rays and as well as planning for further treatment.

**PLEASE NOTE**, this is also the fee for **urgent treatment**.

- BAND 2 £47.00 this includes any one of treatment band 1, and additional treatment such as fillings (one or more), root canal treatment and/or extractions.
- BAND 3
   £203.00 this includes all the treatment in the first two bands plus more complex procedures such as crowns, dentures and bridges.

If you are one of the following you are considered exempt and would not be charged for any treatment:

- Under 18,
- pregnant or had a baby within 12 months,
- under 19 and still in full time education.
- receiving Income support, JSA, Income Related Employment and Support Allowance, Universal Credit, Pension Credit Guarantee Credit or tax credit (exemption cards only).

Proof will need to be shown on at each start of new course of treatment. You also receive free examinations if you are under 25 or over 60 but need to pay for additional treatment if needed.

Charges for private treatments are displayed in our waiting rooms and on our practice website.

# Other information

You can express a preference about which dentist you will see. We will make all reasonable efforts to ensure that the request is met, but this may not always be possible. Should you wish to express a preference of practitioner, please state who you would like to be seen by when booking your appointment.

We would strongly encourage our patients to attend regularly in order to achieve or maintain good oral health. We will undertake a Dental Care assessment during your first appointment in order to ascertain and agree your treatment needs. Written treatment plan including the cost will be provided to you before start of any dental treatment

We endeavour to see all patients and our practice has been designed so patients with disabilities can access care. There are two ground floor surgeries and a WC with full disabled access.

If you do have any disability that you think we need to know about, please give us a call before your appointment and we will do our best to put suitable arrangements in place to accommodate your needs.

Your views are important to us. If you have any suggestion as how we can improve our service, please contact us via our website, post or by telephone. We also have a suggestion box at the entrance of the practice, and we would encourage you to use it.


